- Post-Election Campaign Finance Report: Must be filed after the election, but no later than 4:00 p.m. on Sunday, November 19, 2023. If this report is late and is not filed by 4:00 p.m. Wednesday, November 22, 2023, the candidate is considered to have withdrawn his/her candidacy and forfeited his/her right to office.
- Subsequent Campaign Finance Report(s): July 1, 2024 and every July 1 thereafter by 4:00 p.m. until the campaign has a zero balance.
